RESOURCE ROOM FEE STRUCTURE – (FEES DUE WHEN ENROLLED FOR SERVICES)

Tier 1 Support \$ 1,500

Student will receive support outside of the classroom one – two times per week learning skills that will help the student be more successful in the classroom.

Tier 2 Support \$ 1,600

Student will receive support outside of the classroom three – four times per week learning skills that will help the student be more successful in the classroom.

Tier 3 Support \$ 2,000

Student will receive daily replacement instruction in the resource room in substitution for regular education instruction and assessment. Grades will be issued by the resource room teacher.

AFTER SCHOOL PROGRAM

Our Eagle's Landing after school program is available for children enrolled in PreK3 - grade 8 The program is held in our school cafeteria from (3:15 PM - 6:00 PM) Fees are \$13 - \$20 per day/per child depending on time in the program after school. Eagle's Landing is also offered to Pre-K 2 students until 4:30 PM daily.

TUITION PAYMENT PLAN OPTIONS

1. **MONTHLY:** Monthly tuition is collected by a third-party agency, Vanco Solutions, via ACH from checking or savings account. Students who are enrolled prior to June 1 will pay over 11 months (June - April). Students enrolled after June will pay over 10 months or fewer.
2. **BI-ANNUALLY:** Bi-annual payments are made in two equal installments paid directly to the school office. Payments are due July 10 and January 10. Families will receive an electronic invoice.
3. **ANNUAL with Discount:** Families making a one-time annual payment by May 10, will receive a 3% discount. Families will receive an electronic invoice. Discount is not available for students enrolled after May 10.
4. **ANNUAL no Discount:** Payment is due to the school office by July 10. Families will receive an electronic invoice.

Tuition is non-refundable without 60-day notice. This means you will pay tuition for the days school is scheduled during the 60-day notice period.

MULTI-CHILD DISCOUNT

To make St. Paul education more affordable for larger families, we offer a discount for each additional child enrolled. You will receive a 5% discount on the second student, 10% discount on the third student, and 15% discount on each additional student. Discount applies to youngest child(ren).

GEORGIA STUDENT SCHOLARSHIP ORGANIZATION
